## ORDINANCE NO. 27406

An ordinance changing the name of Industrial Boulevard, between Market Center Boulevard and its southern terminus south of Corinth Street to Riverfront Boulevard; amending Ordinance No. 20860, "Thoroughfare Plan - City of Dallas, Texas," to reflect the street name change; providing a saving clause; providing a severability clause; and providing an effective date.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the name of Industrial Boulevard, between Market Center Boulevard and its southern terminus south of Corinth Street is changed to Riverfront Boulevard.

SECTION 2. That Ordinance No. 20860 is amended to read as shown on Exhibit A, which is attached to and made a part of this ordinance.

SECTION 3. That Ordinance No. 20860 shall remain in full force and effect, save and except as amended by this ordinance.

SECTION 4. That the terms and provisions of this ordinance are severable and are governed by Section 1-4 of Chapter 1 of the Dallas City Code.

SECTION 5. That this ordinance shall take effect on November 10, 2009, and it is accordingly so ordained.
