**WHEREAS**, on March 10, 2010, the City Council awarded Contract No. 09-206E, in the amount of \$913,396.00, by Resolution No. 10-0715, to Jaster-Quintanilla Dallas, LLP, 2105 Commerce Street, Dallas, Texas 75201, to provide engineering design services associated with major maintenance and rehabilitation improvements at the Central Wastewater Treatment Plant; and,

**WHEREAS**, additional engineering services during construction, start-up, and operations are required to proceed with construction of designed improvements; and,

**WHEREAS**, Jaster-Quintanilla Dallas, LLP has submitted an acceptable proposal to provide construction administration and start-up services associated with two construction projects at the Central Wastewater Treatment Plant; and,

**WHEREAS**, the Water Utilities Department recommends that Contract No. 09-206E be increased by \$361,507.00, from \$913,396.00 to \$1,274,903.00; **Now, Therefore,**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:**

**Section 1.** That the proposed Supplemental Agreement No.1 be accepted and that Contract No. 09-206E with Jaster-Quintanilla Dallas, LLP, be revised accordingly.

**Section 2.** That the City Manager be and is hereby authorized to execute the contract after it has been approved as to form by the City Attorney.

**Section 3.** That the City Controller be and is hereby authorized to pay the amount of \$361,507.00 from the Wastewater Capital Improvement Fund as follows:
