## ORDINANCE NO. 27999

An ordinance amending Ordinance No. 24290, passed by the Dallas City Council on June 14, 2000, which amended the zoning ordinances of the City of Dallas, and granted Specific Use Permit No. 1410 for a restaurant with drive-in or drive-through service; amending the property description in Section 1 of that ordinance; amending the conditions in Section 2 of that ordinance; providing a penalty not to exceed \$2,000; providing a saving clause; providing a severability clause; and providing an effective date.

WHEREAS, the city plan commission and the city council, in accordance with the Charter of the City of Dallas, the state law, and the ordinances of the City of Dallas, have given the required notices and have held the required public hearings regarding this amendment to Specific Use Permit No. 1410; and

WHEREAS, the city council finds that it is in the public interest to amend Specific Use Permit No. 1410; Now, Therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DALLAS: SECTION 1. That the property description in Section 1 of Ordinance No. 24290 is amended to read as follows:

<sup>&</sup>quot;BEING all of Lot 1 in City Block 63; fronting 200 feet on the west line of Griffin Street; fronting approximately 100 feet on the north line of Jackson Street; fronting approximately 100 feet on the south line of Commerce Street; and containing approximately 0.46 acres [a tract of land in City Block 63. fronting 200 feet on the west line of Griffin Street, fronting approximately 40 feet on the south line of Jackson Street, fronting approximately 40 feet on the south line of Commerce Street, and all of Poydras Street from the south line of Commerce Street to the north line of Jackson Street, and containing approximately 20,000 square feet of land]."

SECTION 2. That the conditions in Section 2 of Ordinance No. 24290 are amended to

read as follows:

- "1. <u>USE</u>: The only use authorized by this specific use permit is a restaurant with drive-in or drive-through service.
- 2. <u>SITE PLAN</u>: Use and development of the Property must comply with the attached site plan.
- 3. <u>TIME LIMIT</u>: This specific use permit expires on September 22, 2020, but is eligible for automatic renewal for additional 10-year periods pursuant to Section 51A-4.219 of Chapter 51A of the Dallas City Code, as amended. For automatic renewal to occur, the Property owner must file a complete application for automatic renewal with the director before the expiration of the current period. Failure to timely file a complete application will render this specific use permit ineligible for automatic renewal. (Note: The Code currently provides that applications for automatic renewal must be filed after the 180th but before the 120th day before the expiration of the current specific use permit period. The Property owner is responsible for checking the Code for possible revisions to this provision. The deadline for applications for automatic renewal is strictly enforced.) [ten years from the date of passage of this ordinance.]
- 4. <u>OFF-STREET PARKING</u>: A minimum of five off-street parking spaces must be provided in the location shown on the attached site plan.
- 5. <u>LANDSCAPING</u>: Landscaping must be provided as shown on the attached landscaping plan.
- 6. <u>INGRESS AND EGRESS</u>: Ingress and egress must be provided as shown on the attached site plan. Ingress to the Property from Jackson Street is prohibited. "Do Not Enter" signs must be installed at the Jackson Street exit as shown on the attached site plan.
- 7. <u>MAINTENANCE</u>: The [entire] Property must be properly maintained in a state of good repair and neat appearance.
- 8. <u>GENERAL REQUIREMENTS</u>: Use of the Property must comply with all federal and state laws and regulations, and with all ordinances, rules, and regulations of the City of Dallas."

SECTION 3. That a person who violates a provision of this ordinance, upon conviction, is punishable by a fine not to exceed \$2,000.

SECTION 4. That the zoning ordinances of the City of Dallas, as amended, shall remain in full force and effect, save and except as amended by this ordinance.

SECTION 5. That the terms and provisions of this ordinance are severable and are governed by Section 1-4 of Chapter 1 of the Dallas City Code, as amended.

SECTION 6. That this ordinance shall take effect immediately from and after its passage and publication, in accordance with the Charter of the City of Dallas, and it is accordingly so ordained.
