WHEREAS, there is a need to assist single chronically homeless persons by providing rental assistance, in conjunction with support services, to break the cycle of homelessness; and

WHEREAS, the U.S. Department of Housing and Urban Development (HUD) provides for the distribution of Permanent Supportive Housing Grant funds to assist the homeless with rental assistance; and

WHEREAS, HUD approved the City of Dallas' renewal application for Permanent Supportive Housing funds totaling \$701,906;

NOW, THEREFORE;

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

Section 1. That following approval as to form by the City Attorney, the City Manager is hereby authorized to **(1)** accept a Permanent Supportive Housing Grant (Grant No. TX0236B6T001002) in the amount of \$701,906 from the U.S. Department of Housing and Urban Development to provide tenant-based rental assistance and case management for single chronically homeless persons and four staff to administer the program for the period October 1, 2011 through September 30, 2012; **(2)** provide a local match in an amount not to exceed \$36,981; and **(3)** execute the grant agreement and any and all documents required by the grant agreement.

- **Section 2.** That the City Controller is hereby authorized to receive and deposit funds in Fund F332, Dept. HOU, Unit 1648, Revenue Source 6506, in an amount not to exceed \$701,906.
- **Section 3.** That the City Manager is hereby authorized to establish appropriations in Fund F332, Dept. HOU, Unit 1648, in an amount not to exceed \$701,906.
- **Section 4**. That the City Controller is hereby authorized to disburse grant funds from Fund F332, Dept. HOU, Unit 1648, in an amount not to exceed \$701,906, according to the attached Schedule.
- **Section 5.** That the City Controller is hereby authorized to disburse a local match from Fund 0001, Dept. HOU, Unit 4308, in an amount not to exceed \$36,981 (subject to appropriations), according to the attached Schedule.
- **Section 6.** That the City Manager is hereby authorized to reimburse to HUD any expenditures identified as ineligible.

Section 7. That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
