

**WHEREAS**, on February 9, 2011, by Resolution No. 11-0443, Wall Enterprises was awarded a contract for an off-leash dog park, plaza, pavilion, parking lot, site furnishings and landscaping at NorthBark Park located at 4899 Gramercy Oaks Drive;

**WHEREAS**, this Change Order provides for modifications to the scope of work to include additional grading at pond, excavation and concrete sidewalk at NorthBark Park; and installation of a concrete parking lot at Danieldale Park located at 500 West Wheatland Road, in an amount not to exceed \$247,468, increasing the contract amount from \$1,574,019 to \$1,821,487.

## Now, Therefore,

## BE IT RESOLVED BY THE PARK AND RECREATION BOARD AND THE CITY COUNCIL OF THE CITY OF DALLAS:

**SECTION 1.** That the City Manager is hereby authorized to execute an increase to the contract with Wall Enterprises for modifications to the scope of work to include additional grading at pond, excavation and concrete sidewalk at NorthBark Park; and installation of a concrete parking lot at Danieldale Park, in an amount not to exceed \$247,468, increasing the contract amount from \$1,574,019 to \$1,821,487.

**SECTION 2.** That the City Controller is hereby authorized to pay the amount of \$247,468 to Wall Enterprises, as follows:
