WHEREAS, on September 9, 2009, the City Council approved Resolution No. 09-2247 authorizing the acquisition of real property near the intersection of Park Lane and Ridgecrest Road, to be used in conjunction with the Vickery Meadows Branch Library Project; and

WHEREAS, five (5) residents are currently eligible for relocation assistance who were displaced as a direct result of this property acquisition and have vacated the property; and

WHEREAS, Chapter 39A of the Revised Code of Civil and Criminal Ordinances of the City of Dallas provides moving expense and rental assistance payments for individuals displaced by City of Dallas property acquisition activities; and

Now Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That five (5) occupants have been displaced in conjunction with the Vickery Meadows Branch Library Project and are entitled to moving expense and rental assistance payments pursuant to Chapter 39A of the Revised Code of Civil and Criminal Ordinances of the City of Dallas, as described in "Exhibit A".

SECTION 2. That the City Controller is authorized to draw warrants in favor of the five (5) occupants in an aggregate amount not to exceed \$104,011 payable out of Fund 7T42, Department PBW, Unit T645, Activity Code LIBF, Program No. PB06T645, Object 4240, and CT No. as shown on "Exhibit A":
