WHEREAS, on March 10, 2010, Resolution No. 10-0701 authorized Supplemental Agreement No. 1 to the professional services contract with Teague Nall and Perkins, Inc. for additional engineering design services for Street Reconstruction Group 06-619 in the amount of \$31,000.00, increasing the contract from \$258,912.00 to \$289,912.00; and.

WHEREAS, on May 25, 2011, Resolution No. 11-1298 authorized a construction contract with Texas Standard Construction, Ltd. for the reconstruction of street paving, storm drainage and water and wastewater main improvements for Street Reconstruction Group 06-619 in the amount of \$1,999,007.00; and,

WHEREAS, it is now necessary to authorize Change Order No. 1 to the contract with Texas Standard Construction, Ltd. for the construction of additional paving, storm drainage and water and wastewater main improvements to accommodate special traffic needs and miscellaneous items for Street Reconstruction Group 06-619 in the amount of \$98,480.00, increasing the contract from \$1,999,007.00 to \$2,097,487.00.
