

WHEREAS, on October 22, 2008, Resolution No. 08-2867 authorized a professional services contract with HDR Engineering, Inc. for the preliminary engineering for the Ricketts Branch Detention Basin Phase I; and,

WHEREAS, March 10, 2010, Resolution No. 10-0714 authorize Supplemental Agreement No. 1 to the contract with HDR Engineering, Inc. for the engineering design of the Ricketts Branch Detention Basin Project, in the amount of \$331,514, increasing the amount from \$187,211 to \$518,725; and,

WHEREAS, September 30, 2011, Resolution No. 11-2897 authorize Supplemental Agreement No. 2 to the contract with HDR Engineering, Inc. for the engineering design of water and wastewater main relocations, in the amount of \$10,544, increasing the amount from \$518,725 to \$529,269; and,

WHEREAS, bids were received on January 26, 2012, for the construction of channel, drainage, and erosion control improvements for Ricketts Branch Channel Improvements, as follows:



BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

Section 1. That the City Manager is hereby authorized to enter into a contract with The Fain Group, Inc. for the construction of channel, drainage, and erosion control improvements for Ricketts Branch Channel Improvements in an amount not to exceed \$1,644,866.00, this being the lowest responsive bid as indicated by the tabulation of bids.

Section 2. That the City Manager is hereby authorized to execute the contract after it has been approved as to form by the City Attorney.



Section 3. That the City Controller is hereby authorized to disburse funds in accordance with the terms and conditions of the contract from:
