WHEREAS, on December 8, 2010, the City Council awarded Contract No. 10-261/262 in the amount of \$6,816,045.00 by Resolution No. 10-3032, to Atkins Bros. Equipment Co., Inc., 918 West Marshall, Grand Prairie, Texas 75051, for **(1)** an eighteen-month master agreement for water and wastewater small services installations in the amount of \$2,419,295; **(2)** a contract for the installation of water and wastewater mains at seven locations in the amount of \$2,597,300; and **(3)** an eighteen-month master agreement for water and wastewater mainline extensions and emergency mainline installations at various locations in the amount of \$1,799,450; and,

WHEREAS, additional work is necessary to address additional emergency work; and,

WHEREAS, Atkins Bros. Equipment Co., Inc. has submitted an acceptable proposal for this additional work; and,

WHEREAS, the Water Utilities Department recommends that Contract No. 10-261/262 be increased by \$1,011,725.00, from \$6,816,045.00 to \$7,827,770.00; **Now, Therefore,**

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

Section 1. That the proposed Change Order No. 1 be accepted and that Contract No. 10-261/262 with Atkins Bros. Equipment Co., Inc., be revised accordingly.

Section 2. That the City Controller be and is hereby authorized to pay the amount of \$1,011,725.00 from the Water Improvement Series C Fund and Wastewater Improvement Series C Fund as follows:
