ORDINANCE NO. _____

An ordinance amending Ordinance No. 20860, "Thoroughfare Plan - City of Dallas, Texas,"; changing the dimensional classification of Elm Street between Good Latimer Expressway and Exposition Avenue from a four-lane undivided roadway (S-4-U) within 60 feet of right-of-way to a special two-lane undivided roadway (SPCL 2U) within 60 feet of right-of-way and 38 feet of pavement; changing the dimensional classification of Commerce Street between Good Latimer Expressway and Exposition Avenue from a four-lane undivided roadway (S-4-U) within 60 feet of right-of-way to a special two-lane undivided roadway (SPCL 2U) within 60 feet of right-of-way and 38 feet of pavement; providing a saving clause; providing a severability clause; and providing an effective date.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That Ordinance No. 20860, "Thoroughfare Plan - City of Dallas, Texas," is amended by changing the dimensional classification of Elm Street between Good Latimer Expressway and Exposition Avenue from a four-lane undivided roadway (S-4-U) within 60 feet of right-of-way to a special two-lane undivided roadway (SPCL 2U) within 60 feet of right-of-way and 38 feet of pavement to read as shown on the attached Exhibit A.

SECTION 2. That Ordinance No. 20860, "Thoroughfare Plan - City of Dallas, Texas," is amended by changing the dimensional classification of Commerce Street between Good Latimer Expressway and Exposition Avenue from a four-lane undivided roadway (S-4-U) within 60 feet of right-of-way to a special two-lane undivided roadway (SPCL 2U) within 60 feet of right-of-way and 38 feet of pavement to read as shown on the attached Exhibit A.

SECTION 3. That Ordinance No. 20860 shall remain in full force and effect, save and except as amended by this ordinance.

SECTION 4. That the terms and provisions of this ordinance are severable and are governed by Section 1-4 of Chapter 1 of the Dallas City Code, as amended.

SECTION 5. That this ordinance shall take effect immediately from and after its passage and publication in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so ordained.
