WHEREAS, the City of Dallas owns certain land in City Block A/8652, Dallas, Dallas County, Texas which is used for the City's Pavaho Pump Station, being the same land conveyed to the City of Dallas in that one certain instrument recorded at Volume 74029, Page 777, Official Real Property Records of Dallas County Texas; and

WHEREAS, Oncor Electric Delivery Company, LLC has requested an Easement and Right-of-Way containing approximately 3,906 square feet of land, being more fully described in Exhibit "A", attached hereto and incorporated herein for all purposes (the Easement); for the construction, maintenance and use of power lines and electric transformer facilities to service the Pavaho Pump Station; and

WHEREAS, the City of Dallas needs and desires said utility service to the Pavaho Pump Station and will be benefitted by the granting of said Easement and Right-of-Way;

Now Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the City Manager or her designee is authorized to execute and deliver to Oncor Electric Delivery Company, LLC, an Easement and Right-of-Way to be attested by the City Secretary upon approval as to form by the City Attorney, for the construction, maintenance and use of power lines and electric transformer facilities to service the City's facilities, including the Pavaho Pump Station, on the approximately 3,906 square feet of land described in Exhibit "A".

SECTION 2. That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
