**WHEREAS,** on March, 28, 2001, Resolution No. 01-0962, authorized Supplemental Agreement No. 1 to the professional services contract with Huitt-Zollars, Inc. for contract documents for the landscape plan at Dallas Love Field in the amount of \$62,281, increasing the contract from \$245,000 to \$307,281; and,

**WHEREAS,** on April 9, 2002, Administrative Action No. 02-1166 authorized Supplemental Agreement No. 2 to the professional services contract with Huitt-Zollars, Inc. for the design and preparation of construction documents in the amount of \$8,500, increasing the contract from \$307,281 to \$315,781; and,


**WHEREAS,** on April, 10, 2002, Resolution No. 02-1207, authorized Supplemental Agreement No. 3 to the professional services contract with Huitt-Zollars, Inc. for contract documents for the landscape plan at Dallas Love Field in the amount of \$29,957.50, increasing the contract from \$315,781.00 to \$345,738.50; and,

**WHEREAS,** on May 29, 2002, Administrative Action No. 02-1568 authorized Supplemental Agreement No. 4 to the professional services contract with Huitt-Zollars, Inc. for construction administration services in the amount of \$14,942.00, increasing the contract from \$345,738.50 to \$360,680.50; and,

**WHEREAS,** on December 6, 2002, Administrative Action No. 02-3440 authorized Supplemental Agreement No. 5 to the professional services contract with Huitt-Zollars, Inc. for design services for Shorecrest Drive at Dallas Love Field in the amount of \$2,875.00, increasing the contract amount from \$360,680.50 to \$363,555.50; and,

**WHEREAS**, on June 27, 2003, Administrative Action No. 03-1968 authorized Supplemental Agreement No. 6 to the professional services contract with Huitt-Zollars, Inc. for the design and preparation of construction documents in the amount of \$5,400.00, increasing the contract amount from \$363,555.50 to \$368,955.50; and,

WHEREAS, on May 23, 2011, Administrative Action No. 11-1494 authorized Supplemental Agreement No. 7 to the professional services contract with Huitt-Zollars, Inc. for contract documents for the landscape plan at the corner of Mockingbird Lane and Denton Drive, Dallas Love Field, in the amount of \$24,800.00, increasing the contract from \$368,955.50 to \$393,755.50; and,

**Section 1.** That the City Manager is hereby authorized to execute a contract with Cole Construction, Inc. to provide landscape and irrigation construction services for the Mockingbird Lane and Denton Drive Landscape Project at Dallas Love Field Airport in an amount not to exceed \$241,343, after it has been approved as to form by the City Attorney.

**Section 2.** That the City Controller is authorized to disburse funds in accordance with the terms and conditions of the contract from:
