WHEREAS, the City of Dallas recognizes the emerging evolution of transportation infrastructure in the City of Dallas and the importance of providing an integrated transportation system that balances the needs of pedestrians, transit, bicycles and automobiles; and

WHEREAS, the City Council adopted on June 8, 2005, the Comprehensive Transportation Plan for the Dallas Central Business District that recommended a balanced transportation network and the development of a streetcar system to enhance circulation; by Resolution No. 05-1759; and

WHEREAS, it has been recognized that the principles of Sustainable Livable Communities are essential for the vitality of the City and the development of a Streetcar System for Downtown and the surrounding communities is an essential component in establishing sustainable communities; and

WHEREAS, on August 4, 2010, the City of Dallas committed to the development of a streetcar line from Union Station in Downtown Dallas to North Oak Cliff near Methodist hospital through Interlocal Agreements with DART and NCTCOG; and

WHEREAS, the City of Dallas is the recipient of an additional \$5,800,000 grant from the North Central Texas Council of Governments Regional Transportation Council (RTC) for the construction of a streetcar system, which supplements a \$10,000,000 grant from the North Central Texas Council of Governments RTC and a \$26,000,000 grant from the Federal Transit Administration awarded through the NCTCOG.

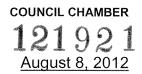
