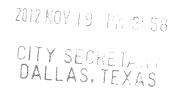

SUBJECT Correction to Council Resolution No. 12-2278, September 12, 2012

WHEREAS, the bid submitted by Archer Western Construction, LLC, 2121 Avenue J, Suite 103, Arlington, Texas 76006, in the amount of \$3,646,050.00, is the lowest and best of all bids received; **Now, Therefore,**

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

Section 1. That the bid submitted by Archer Western Construction, LLC in the amount of \$3,646,050.00, for doing the work covered by the plans, specifications, and contract documents, Contract No. 12-099, be accepted.

Section 2. That the City Manager be and is hereby authorized to execute a contract with Archer Western Construction, LLC, for the rehabilitation of the Carrollton, California Crossing, and Frasier Dams, after having approval of the contract documents by the City Attorney.

Section 3. That the City Manager is authorized to transfer appropriations from fund 0115, Department DWU, Unit PW31, Object 4320 to fund 2115, Department DWU, Unit PW10, Object 4550, in an amount not to exceed \$3,646,050.00.

Section 4. That the City Controller be and is hereby authorized to pay the amount of \$3,646,050.00 from the Water Capital Improvement Fund as follows:
