WHEREAS, on September 12, 2012, the City Council approved Resolution No. 12-2272 authorizing the acquisition of 5811 West Kiest Boulevard to be used in conjunction with the Future Fire Station Project; and

WHEREAS, Walter Waggoner and Connie Poindexter will be displaced as a direct result of this property acquisition and will vacate the property; and

WHEREAS, Chapter 39A of the Revised Code of Civil and Criminal Ordinances of the City of Dallas provides moving expense and rental assistance payments for individuals displaced by City of Dallas property acquisition activities; and

Now Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

Section 1. That Walter Waggoner and Connie Poindexter will be displaced in conjunction with the Future Fire Station Project and are entitled to moving expense and rental assistance payments pursuant to Chapter 39A of the Revised Code of Civil and Criminal Ordinances of the City of Dallas.

Section 2. That Walter Waggoner and Connie Poindexter are eligible to receive a moving expense payment in an amount up to \$2,350 and a rental assistance payment in an amount up to \$9,870.

Section 3. That the City Controller is authorized to draw warrants in favor of Walter Waggoner and Connie Poindexter in an amount not to exceed \$12,220 for moving expense and rental assistance payments.

These warrants are to be paid as follows:
