WHEREAS, on August 12, 2010, Administrative Action No. 10-2537 authorized Supplemental Agreement No. 1 to the contract with Teague Nall and Perkins, Inc. for additional survey services for right-of-way acquisition and upgrading approximately 520 linear feet of water and wastewater main outside the original scope in the amount of \$23,163.50, increasing the contract from \$198,006.40 to \$221,169.90; and,

WHEREAS, on April 13, 2011, Resolution No. 11-0939 authorized Supplemental Agreement No. 2 to the contract with Teague Nall and Perkins, Inc. for additional survey services required to provide signed and sealed horizontal and vertical control sheets for construction and signed and sealed parcel maps and descriptions and other documents for 13 parcels of proposed right-of-way in the amount of \$62,611.50, increasing the contract from \$221,169.90 to \$283,781.40; and,

WHEREAS, on May 25, 2011, Resolution No. 11-1295 authorized a construction contract with SYB Construction Company, Inc. for the reconstruction of street paving, storm drainage and water and wastewater main improvements for Street Reconstruction Group 06-612, Bexar Street from Brigham Lane to Myrtle Street and Henderson Avenue from Winslow Avenue to Oleander Street in the amount of \$1,405,066.25; and,

WHEREAS, on March 18, 2012, Administrative Change Order No. 12-0765 authorized Change Order No. 1 to the contract with SYB Construction Company, Inc. to extend the water main replacements on Henderson Avenue from Winslow Avenue to Oleander Street in the amount of \$21,838.00, increasing the contract from \$1,405,066.25 to \$1,426,904.25; and.

WHEREAS, on April 19, 2012, Administrative Change Order No. 12-1080 authorized Change Order No. 2 to the contract with SYB Construction Company, Inc. to extend pavement reconstruction to the intersections at Oleander Street and Winslow Avenue in the amount of \$24,934.46, increasing the contract from \$1,426,904.25 to \$1,451,838.71; and,

WHEREAS, it is now necessary to authorize Change Order No. 3 to the contract with SYB Construction Company, Inc. to extend the original street paving and water and wastewater main replacement limits for Street Reconstruction Group 06-612 on Bexar Street from Brigham Lane to Myrtle Street and Myrtle Street from Lawrence Street to Marder Street in the amount of \$122,564.00, increasing the contract from \$1,451,838.71 to \$1,574,402.71.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

Section 1. That the City Manager is hereby authorized to execute Change Order No. 3 to the contract with SYB Construction Company, Inc. to extend the original street paving and water and wastewater main replacement limits for Street Reconstruction Group 06-612 on Bexar Street from Brigham Lane to Myrtle Street and Myrtle Street from Lawrence Street to Marder Street in the amount of \$122,564.00, increasing the contract from \$1,451,838.71 to \$1,574,402.71, after it has been approved as to form by the City Attorney.
