## ORDINANCE NO. 28867

An ordinance amending Ordinance No. 28685, by altering Section 9 thereof; providing for consideration to be paid to the City of Dallas; providing for payment of the publication fee; providing a saving clause; and providing an effective date.

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

**SECTION 1.** That Ordinance No. 28685 adopted by the City Council of the City of Dallas on June 27, 2012, be and the same is hereby amended by altering Section 9 to read as follows:

"SECTION 9. That as a condition of this abandonment and as a part of the consideration for the quitclaim made herein, GRANTEE shall record a final replat of the adjoining properties within one year of the effective date of this ordinance showing the fee simple dedication of not less than [108,101] 100,636 square feet of needed right-of-way in City Blocks A/5914, B/5914, and C/5914. This final replat shall be recorded by GRANTEE in the official real property records of the county in which the abandoned areas and the dedicated property are located, after its approval by the City Plan Commission of the City of Dallas. This abandonment shall not be effective unless and until this dedication is completed and failure to record a final replat in accordance with the terms of this section shall render this ordinance null and void and of no further effect. Further, the final replat shall be recorded in the official real property records of the county in which the abandoned area is located before a certified copy of this ordinance shall be delivered to GRANTEE."

SECTION 2. That as consideration for amending Ordinance No. 28685, Sphinx Development Corporation and SDC Sachse Senior Villas, L.L.C., agree to pay monetary consideration in the sum of FIVE THOUSAND FOUR HUNDRED AND NO/100 (\$5,400.00) DOLLARS to the City of Dallas, and, by its tender thereof, accept the terms and conditions of this ordinance.

**SECTION 3.** That the City Controller is authorized to deposit the sum paid by **GRANTEE** pursuant to Section 2 above in the General Fund 0001, Department DEV, Balance Sheet 0519 and Department of Sustainable Development and Construction-Real Estate Division shall be reimbursed for the cost of obtaining the legal description, appraisal and other administrative costs incurred. The reimbursement proceeds shall be deposited in General Fund 0001, Department DEV, Unit 1183, Object 5011 and any remaining proceeds shall be transferred to the General Capital Reserve Fund 0625, Department BMS, Unit 8888, Revenue Source 8416.

**SECTION 4.** That the terms and conditions of Ordinance No. 28685 shall remain in full force and effect except as amended hereby.

**SECTION 5.** That the City Secretary is hereby authorized and directed to certify a copy of this ordinance for recordation in the official real property records of the county in which the abandonment area is located, which certified copy shall be delivered to the Director of Sustainable Development and Construction, or designee. Upon receipt of the fee for the publishing of this ordinance, which **GRANTEE** shall likewise pay, the Director of Sustainable Development and Construction, or designee, shall deliver to **GRANTEE** a certified copy of this ordinance. The Director of Sustainable Development and Construction, or designee, shall be the sole source for receiving certified copies of this ordinance for one (1) year after its passage.

**SECTION 5.** That this ordinance shall take effect immediately from and after its passage and publication in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so ordained.
