

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:**

**Section 1.** That the City Manager is authorized to execute **(1)** a five-year acquisition contract for the purchase and implementation of a bait car system for Dallas Police Department enforcement in the amount of \$1,018,600.00; and **(2)** a five-year service contract for maintenance and support of the bait car system in the amount of \$363,079.00 with Supercircuits, Inc. (387965); **(3)** a five-year acquisition contract for the purchase and implementation of asset tracking system in the amount of \$818,100.00; and **(4)** a five-year service contract for maintenance and support of the asset tracking system in the amount of \$197,500.00 with CovertTrack Group, Inc. (VS0000070404), in a total amount not exceed \$2,397,279.00, upon approval as to form by the City Attorney. If the service was bid or proposed on an as needed, unit price basis for performance of specified tasks, payment to Supercircuits, Inc. and CovertTrack Group, Inc. shall be based only on the amount of the services directed to be performed by the City and properly performed by Supercircuits, Inc. and CovertTrack Group, Inc. under the contract.

**Section 2.** That the City Controller is authorized to disburse funds from the following appropriations in an amount not to exceed \$2,397,279.00 (subject to annual appropriations):
