WHEREAS, Dallas County Schools provides bus services to the students of Dallas Public Schools; and

WHEREAS, the Park and Recreation Department of the City of Dallas desires to transport children and adults to various programs and activities to include Senior Citizens, After-School, Golf and Tennis, Send a Kid to Camp, and Summer Camp; and, the following Divisions of the Park and Recreation Department will utilize the bus services: Recreation Services, Special Services, Community Development Block Grant, and Youth Services; and

WHEREAS, both Dallas County Schools and the City of Dallas are political subdivisions of the State of Texas and are authorized to enter into an agreement pursuant to the provisions of the Texas Interlocal Cooperation Act, Chapter 791 of the Texas Government Code; **Now, Therefore,**

BE IT RESOLVED BY THE PARK AND RECREATION BOARD AND THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That a twenty-eight-month Interlocal Agreement be authorized with Dallas County Schools to transport participants to various program and activities from May 23, 2013 through September 30, 2015, subject to the terms and conditions of the agreement.

SECTION 2. That the President of the Park and Recreation Board and the City Manager are authorized to execute the agreement after approval as to form by the City Attorney's Office.

SECTION 3. That the City Controller be and is hereby authorized to disburse funds to Dallas County Schools (Vendor #349114) from the following appropriations in an amount not to exceed \$875,000 (subject to annual appropriations):
