WHEREAS, the City of Dallas held a general election on Saturday, May 11, 2013; and
WHEREAS, no candidate for Member of Council Place 5 or 14 received sufficient votes to be elected at that election; and,

WHEREAS, the City Council has ordered a runoff election to be held on Saturday, June 15, 2013, in City Council Districts 5 and 14; and,

WHEREAS, the City had contracted with the Dallas County Elections Administrator for election services for the May 11, 2013 general election in accordance with Subchapter D of Chapter 31 of the Texas Election Code; and,

WHEREAS, the election services contract provides that, in the event a runoff election is necessary, the Elections Administrator will furnish the City Secretary with an itemized list of additional estimated election expenses to be deposited in the election services contract fund after authorization by the City Council, and that the Elections Administrator will continue to perform or supervise the performance of election duties and functions necessary for the proper administration of the runoff election; and; Now, Therefore,

## BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

Section 1. That the election services agreement between the City of Dallas and Dallas County is extended to provide for services for the runoff election to be held Saturday, June 15, 2013.

Section 2. That the City Manager is hereby authorized to increase the joint elections agreement and election services contract between the City of Dallas, Dallas County, and various other jurisdictions within Dallas County in an amount not to exceed $\$ 408,635.55$, from $\$ 449,708,04$ to $\$ 858,343.59$.

Section 3. That the City Controller is hereby authorized to disperse an amount not to exceed $\$ 408,635.55$ from Fund 0001, Department SEC, Unit 1190, Object Code 3070, Encumbrance No. SEC1190E555, Vendor 014003 for deposit in the election services contract fund as the City's estimated share of the costs of the general, special and runoff elections.

Section 4. That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
