WHEREAS, The Black Academy of Arts and Letters, Inc. was organized to preserve, promote, perpetuate, foster and cultivate the arts and letters of African Americans; and

WHEREAS, the Dallas Council on January 27, 1999 authorized the City Manager to approve a lease agreement for a period of fifteen years, by Resolution No. 99-0359; and

WHEREAS, subject to annual appropriation by the City Council TBAAL receives an annual service agreement from the Office of Cultural Affairs which is the primary source of funding for it's cultural and educational programming operations; and

WHEREAS, The Black Academy of Arts and Letters, Inc. wishes to seek approval of a new thirty year lease.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

Section 1. That the City Manager is authorized to enter into a lease agreement with The Black Academy of Arts and Letters, Inc. for Kay Bailey Hutchison Convention Center Dallas Theater space for a term of thirty (30) years, plus two (2) five (5) year extension options at rental rates of \$135,000.00 (this rental rate will be in effect only until proposed additional space is turned over to TBAAL, subject to City Council appropriation).
