**WHEREAS,** on June 23, 2010, the City Council awarded Contract No. 10-029E in the amount of \$1,163,554.00, by Resolution No.10-1640 to Carollo Engineers, P.C., 14785 Preston Road, Suite 950, Dallas, Texas 75254, to provide engineering services for the Bachman Water Treatment Plant water quality improvements; and,

**WHEREAS,** on March 28, 2012, the City Council awarded Supplemental Agreement No. 1, in the amount of \$6,296,114.00, by Resolution No. 12-0951, to Carollo Engineers, P.C., for additional engineering and design services for the Bachman Water Treatment Plant water quality improvements; and,

WHEREAS, on August 14, 2013, the City Council awarded Supplemental Agreement No. 2, in the amount of \$1,240,754.00, by Resolution No. 13-1334, to Carollo Engineers, Inc. (formerly Carollo Engineers, P.C.), for additional engineering services associated with water quality improvements at the Bachman Water Treatment Plant; and,

**WHEREAS,** additional engineering services related to water quality improvements at the Bachman Water Treatment Plant are required; and,

**WHEREAS,** Carollo Engineers, Inc., has submitted an acceptable proposal to provide these engineering services; and,

WHEREAS, Dallas Water Utilities recommends that Contract No. 10-029E be increased by \$1,039,653.00, from \$8,700,422.00 to \$9,740,075.00.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

**Section 1.** That the proposed Supplemental Agreement No. 3 be accepted and that Contract No. 10-029E with Carollo Engineers, Inc., be revised accordingly.

**Section 2.** That the City Manager is hereby authorized to execute the contract after it has been approved as to form by the City Attorney.

**Section 3.** That the City Controller is hereby authorized to pay the amount of \$1,039,653.00 from the Water Capital Improvement Fund as follows:
