WHEREAS, the City of Dallas owns tracts of land which are used for Lake Ray Hubbard; and

WHEREAS, the City of Rowlett has requested a wastewater easement on said land for the construction, maintenance and use of wastewater facilities, containing approximately 2,760 square feet of land, located in Abstract No. 94, Dallas County, Texas, the boundary of which property being more particularly described in "Exhibit A", attached hereto and made a part hereof of all purposes; and

WHEREAS, the Interlocal Agreement and Lease between the City of Dallas and the City of Rowlett dated January 22, 2001, contemplates the granting of easement rights.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That pursuant to the Interlocal Agreement and Lease, the City Manager is authorized to execute a wastewater easement to be attested by the City Secretary upon approval as to form by the City Attorney for approximately 2,760 square feet of land, located in Abstract No. 94, Dallas County, Texas to the City of Rowlett as **GRANTEE**.


