

WHEREAS, on November 7, 2006, Dallas voters approved the use of General Obligation Bonds to acquire property for future City facilities; and

WHEREAS, David Galaviz and Pauline Galaviz will be displaced as a direct result of this property acquisition and will vacate the property; and

WHEREAS, Chapter 39A of the Revised Code of Civil and Criminal Ordinances of the City of Dallas provides moving expense and rental assistance payments for individuals displaced by City of Dallas property acquisition activities; and

WHEREAS, on October 28, 2009, the City Council approved Resolution No. 09-2646 authorizing the acquisition of 2958 Gloyd Street located in the Cadillac Heights neighborhood, to be used in conjunction with the construction of future City facilities.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That David Galaviz and Pauline Galaviz will be displaced in conjunction with the construction of future City facilities and are entitled to moving expense and rental assistance payments pursuant to Chapter 39A of the Revised Code of Civil and Criminal Ordinances of the City of Dallas.

SECTION 2. That David Galaviz and Pauline Galaviz are eligible to receive a moving expense payment in an amount up to \$1,750 and a rental assistance payment in an amount up to \$6,384.

SECTION 3. That the Chief Financial Officer is authorized to draw warrants in favor of David Galaviz and Pauline Galaviz in an amount not to exceed \$8,134 for moving expense and last resort calculated rental assistance payments.

These warrants are to be paid as follows:
