WHEREAS, on October 26, 2016, City Council authorized the acquisition of 5420 Barber Avenue to be used in conjunction with the Mill Creek/Peaks Branch/State-Thomas Drainage Relief Tunnel Project by Resolution No. 16-1756; and

WHEREAS, Betty Taylor will be displaced as a direct result of this property acquisition and will vacate the property; and

WHEREAS, Chapter 39A of the Revised Code of Civil and Criminal Ordinances of the City of Dallas provides moving expense and rental assistance payments for individuals displaced by City of Dallas property acquisition activities.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That Betty Taylor will be displaced in conjunction with the construction of Mill Creek/Peaks Branch/State-Thomas Drainage Relief Tunnel Project and is entitled to moving expense and rental assistance payments pursuant to Chapter 39A of the Revised Code of Civil and Criminal Ordinances of the City of Dallas.

SECTION 2. That Betty Taylor is eligible to receive a moving expense payment in an amount up to \$1,600.00 and a rental assistance payment in an amount up to \$22,831.62.

SECTION 3. That the Chief Financial Officer is hereby authorized to draw warrants in favor of Betty Taylor, in an amount not to exceed \$24,431.62 for moving expense and rental assistance payments.

These warrants are to be paid as follows:
