ORDINANCE NO. 30557

An ordinance changing the zoning classification on the following property:

BEING part of Tract 4 within City Block 7609 located along the northwestern line of Interstate Highway 20 approximately 778 feet west of the western line of Lancaster Road; and containing approximately 8.209 acres,

from an R-7.5(A) Single Family District and an MF-2(A) Multifamily District to a CR Community Retail District; providing a penalty not to exceed \$2,000; providing a saving clause; providing a severability clause; and providing an effective date.

WHEREAS, the city plan commission and the city council, in accordance with the Charter of the City of Dallas, the state law, and the ordinances of the City of Dallas, have given the required notices and have held the required public hearings regarding the rezoning of the property described in this ordinance; and

WHEREAS, the city council finds that it is in the public interest to change the zoning classification; Now, Therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the zoning classification is changed from an R-7.5(A) Single Family District and an MF-2(A) Multifamily District to a CR Community Retail District on the property described in Exhibit A, which is attached to and made a part of this ordinance (“the Property”).

SECTION 2. That, pursuant to Section 51A-4.701 of Chapter 51A of the Dallas City Code, as amended, the property description in Section 1 of this ordinance shall be construed as including the area to the centerline of all adjacent streets and alleys.

SECTION 3. That the building official shall not issue a building permit or a certificate of occupancy for a use on the Property until there has been full compliance with the Dallas Development Code, the construction codes, and all other ordinances, rules, and regulations of the City of Dallas.

SECTION 4. That a person who violates a provision of this ordinance, upon conviction, is punishable by a fine not to exceed \$2,000.

SECTION 5. That the zoning ordinances of the City of Dallas shall remain in full force and effect, save and except as amended by this ordinance.


SECTION 6. That the terms and provisions of this ordinance are severable and are governed by Section 1-4 of Chapter 1 of the Dallas City Code, as amended.

SECTION 7. That this ordinance shall take effect immediately from and after its passage and publication, in accordance with the Charter of the City of Dallas, and it is accordingly so ordained.

THENCE South 20 degrees 08 minutes 39 seconds East, a total distance of 250.00 feet;

THENCE South 69 degrees 51 minutes 21 seconds West, a total distance of 315.04 feet;

THENCE South 71 degrees 39 minutes 35 seconds West, a total distance of 399.22 feet;

THENCE North 21 degrees 21 minutes 33 seconds West, a total distance of 296.98 feet;

THENCE along a curve to the right, having a central angle of 06 degrees 44 minutes 33 seconds, a radius of 1945.00 feet, and a chord bearing and distance of North 17 degrees 59 minutes 17 seconds West, 228.76 feet, a total arc length of 228.89 feet;

THENCE North 71 degrees 39 minutes 35 seconds East, a total distance of 205.54 feet;

THENCE along a curve to the left, having a central angle of 26 degrees 39 minutes 47 seconds, a radius of 600.00 feet, and a chord bearing and distance of North 58 degrees 19 minutes 41 seconds East, 276.70 feet, a total arc length of 279.21 feet;

THENCE South 55 degrees 03 minutes 45 seconds East, a total distance of 410.87 feet to the POINT OF BEGINNING and containing a total area of 357,568.15 square feet, or 8.209 acres of land, more or less.
