ORDINANCE NO. 30732

An ordinance changing the name of Maham Road, between Central Expressway and Spring Valley Road to Esperanza Road; amending Ordinance No. 20860, "Thoroughfare Plan - City of Dallas, Texas," to reflect the street name change; providing a saving clause; providing a severability clause; and providing an effective date.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the name of Maham Road, between Central Expressway and Spring Valley Road is changed to Esperanza Road.

SECTION 2. That Ordinance No. 20860 is amended to read as shown on the attached Exhibit A.

SECTION 3. That Ordinance No. 20860 shall remain in full force and effect, save and except as amended by this ordinance.

SECTION 4. That the terms and provisions of this ordinance are severable and are governed by Section 1-4 of Chapter 1 of the Dallas City Code.

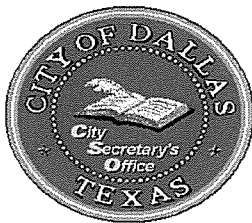
