ORDINANCE NO. 31069

An ordinance amending Article 751, "PD 751," of Chapter 51P, "Dallas Development Code: Planned Development District Regulations," of the Dallas City Code; providing a new Tract 1A development plan/Tract 1, Tract 2 conceptual plan; providing a new landscape plan; amending Ordinance No. 26433 passed by the Dallas City council on August 23, 2006 by providing a revised property description; providing a penalty not to exceed $\$ 2,000$; providing a saving clause; providing a severability clause; and providing an effective date.

WHEREAS, the city plan commission and the city council, in accordance with the Charter of the City of Dallas, the state law, and the ordinances of the City of Dallas, have given the required notices and have held the required public hearings regarding this amendment to the Dallas City Code; and

WHEREAS, the city council finds that it is in the public interest to amend Article 751 as specified in this ordinance; Now, Therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DALLAS:
SECTION 1. That the Tract 1A development plan/Tract 1, Tract 2 conceptual plan, Exhibit 751A of Article 751, "PD 751," of Chapter 51P of the Dallas City Code, is replaced by the Exhibit 751A attached to this ordinance.

SECTION 2. That the landscape plan, Exhibit 751B of Article 751, "PD 751," of Chapter 51P of the Dallas City Code, is replaced by the Exhibit 751B attached to this ordinance.

SECTION 3. That development of this district must comply with the full-scale versions of Exhibit 751A (development plan) and Exhibit 751B (landscape plan) attached to this ordinance. Reduced-sized versions of these plans shall be provided in Chapter 51P. Permits shall be issued based on information provided on the full-scale versions of the plans.

SECTION 4. That Exhibit A (property description) attached to Ordinance No. 26433 is replaced by the Exhibit A attached to this ordinance.

SECTION 5. That a person who violates a provision of this ordinance, upon conviction, is punishable by a fine not to exceed $\$ 2,000$.

SECTION 6. That Chapter 51P of the Dallas City Code, as amended, shall remain in full force and effect, save and except as amended by this ordinance.

SECTION 7. That the terms and provisions of this ordinance are severable and are governed by Section 1-4 of Chapter 1 of the Dallas City Code, as amended.

SECTION 8. That this ordinance shall take effect immediately from and after its passage and publication, in accordance with the Charter of the City of Dallas, and it is accordingly so ordained.
