WHEREAS, on December 12, 2007, City Council authorized a professional services contract with Jacobs Engineering Group, Inc. for the engineering design of Cesar Chavez Boulevard (formerly Central Expressway) from Commerce Street to Live Oak Street by Resolution No. 07-3794; and

WHEREAS, on April 23, 2008, City Council authorized a professional services contract with EJES, Inc. for engineering design services for the reconstruction of Pearl Street from Commerce Street to Live Oak Street by Resolution No. 08-1278; and

WHEREAS, on April 22, 2009, City Council authorized approval of the recommended plan for the proposed alignment of Cesar Chavez Boulevard (formerly Central Expressway) from Commerce Street to Live Oak Street from its current alignment to the proposed alignment by Resolution No. 09-1082; and

WHEREAS, on September 28, 2011, City Council authorized a contract with Tiseo Paving Company for the construction of street paving, storm drainage, streetscape, traffic signal upgrades, water and wastewater main improvements for Cesar Chavez Boulevard (Central Expressway) from Commerce Street to Live Oak Street and Pearl Expressway from Commerce Street to Live Oak Street, in an amount not to exceed \$12,473,919.31, by Resolution No. 11-2548; and

WHEREAS, the City is the owner of the public right-of-way generally located on Cesar Chavez Boulevard between Commerce Street and Elm Street ("Project Area"), as shown in Exhibit A; and

WHEREAS, the City has an existing contract with Tiseo Paving Company regarding construction of certain improvements within the Project Area pursuant to Resolution No. 11-2548 ("Original Contract") approved by the Dallas City Council on September 28, 2011; and

WHEREAS, Ghost Sign Development, LLC, a Delaware limited liability company and an abutting property owner ("Developer") desires to beautify the Project Area by providing certain enhanced infrastructure improvements that are different from the improvements set forth in the Original Contract, including but not limited to, pedestrian lighting, pavers, traffic signals and landscaping ("Enhanced Improvements"), as shown in Exhibits B-1, B-2, B-3 and B-4; and

WHEREAS, the City is desirous of accepting the Enhanced Improvements; and

WHEREAS, to facilitate the Enhanced Improvements, a Thoroughfare Plan amendment is required; and

WHEREAS, the Developer submitted an amendment to the City of Dallas Thoroughfare Plan to the City's Plan Commission for the purpose of modifying the configuration of Jackson Street south of the Project Area; and

WHEREAS, due to the time needed to process the Thoroughfare Plan amendment, the parties agree that a delay in completing the City's work under the Original Contract is expected; and

WHEREAS, the Developer has agreed to reimburse City for any additional costs to construct the Enhanced Improvements, if any; and

WHEREAS, the City has estimated potential costs of \$65,000.00 if the Developer fails to construct the Enhanced Improvements and Developer has agreed to deposit \$65,000.00 in an escrow account ("Escrow Payment") to reimburse City for such costs if needed; and

WHEREAS, the parties desire to enter into this agreement in order to allow the Enhanced Improvements to be constructed by the Developer in accordance with the terms and conditions contained in the agreement.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the City Manager is hereby authorized to execute a development agreement with Ghost Sign Development LLC, a Delaware limited liability company ("Developer"), approved as to form by the City Attorney, for the design, construction, repair and maintenance of certain enhanced infrastructure improvements ("Enhanced Improvements") at Cesar Chavez Boulevard between Commerce and Elm Streets ("Project Area").

SECTION 2. That the Chief Financial Officer is hereby authorized to receive and deposit funds in an amount not to exceed \$65,000.00 ("Escrow Payment") in the Capital Projects Reimbursement Fund, Fund 0556, Department PBW, Unit U779, Balance Sheet Account 0745, if the Enhanced Improvements are not completed and accepted in accordance with the development agreement.

SECTION 3. That the City Manager is hereby authorized to increase appropriations in an amount not to exceed \$65,000.00 in the Capital Projects Reimbursement Fund, Fund 0556, Department PBW, Unit U779, Object Code 4599, if the Enhanced Improvements are not completed and accepted in accordance with the development agreement.

SECTION 4. That the City Manager, alternatively, is hereby authorized to execute an escrow release, approved as to form by the City Attorney, to release any claim against the Escrow Payment if the Enhanced Improvements are completed and accepted by the City in accordance with the development agreement.

SECTION 5. That the term of the agreement commences on execution and terminates 20 years thereafter, unless terminated at an earlier date in accordance with the terms of the agreement and shall be able to be extended for two consecutive five-year periods, subject to the City's approval and consent, if the Developer petitions to have the agreement extended.

SECTION 6. That this contract is designated as Contract No. PBW-2019-00009435.

SECTION 7. That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.




EXHIBIT A - Project Scope Area






EXHIBIT B-1 - Crosswalk & Bike Lane Paving Materials








EXHIBIT B-3 - Planting





CITY PROPOSED PLANTING PALLET






MUHLENBERGIA CAPILLARIS (792 S.F. TOTAL)
