ORDINANCE NO. 31302

An ordinance amending Ordinance No. 20860, "Thoroughfare Plan - City of Dallas, Texas,"; deleting Beaumont Street from Ervay Street to Harwood Street; providing a saving clause; providing a severability clause; and providing an effective date.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That Ordinance No. 20860, "Thoroughfare Plan - City of Dallas, Texas," is amended by deleting Beaumont Street from Ervay Street to Harwood Street to read as shown on the attached Exhibit A.

SECTION 2. That Ordinance No. 20860 shall remain in full force and effect, save and except as amended by this ordinance.

SECTION 3. That the terms and provisions of this ordinance are severable and are governed by Section 1-4 of Chapter 1 of the Dallas City Code, as amended.


