ORDINANCE NO. 31415

An ordinance amending Ordinance No. 13262, "Dallas Central Business District Streets and Vehicular Circulation Plan,"; changing the functional characteristics of Bryan Street between Leonard Street and Hawkins Street from a two-track light rail transit (LRT) mall with two eastbound access lanes on the southside in 79 feet of right-of-way to a two-track LRT mall with one eastbound access lane on the southside in 79 feet of right-of-way; providing a saving clause; providing a severability clause; and providing an effective date.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the Ordinance No. 13262, "Dallas Central Business District Streets and Vehicular Circulation Plan," is amended by changing the functional characteristics of Bryan Street between Leonard Street and Hawkins Street from a two-track light rail transit (LRT) mall with two eastbound access lanes on the southside in 79 feet of right-of-way to a two-track LRT mall with one eastbound access lane on the southside in 79 feet of right-of-way to read as shown on the attached Exhibit A.

SECTION 3. That Ordinance No. 13262 shall remain in full force and effect, save and except as amended by this ordinance.

SECTION 4. That the terms and provisions of this ordinance are severable and are governed by Section 1-4 of Chapter 1 of the Dallas City Code.


